In case the bank details belong to the Creditor's lawyer or legal representative, it must be presented an up-to-date letter of attorney with specific authorization, by public instrument, with recognized firm or duly legalized, under the terms of applicable legislation.

Creditors must inform their bank details and present the required documentation to receive the credit apportionment **within 60 (sixty) days of the call publication**, under penalty of missing the creditor apportionment, excepted the credits reservations, under the terms of article 149, 1<sup>st</sup> and 2<sup>nd</sup> paragraphs of Law 11.101/2005.
